9. No amendment to the Trust Dees shall be made which may prove to be repugnant to the provisions of Section 2(5)11 to 13 and 80-G of the Income Tax Act.1961.
10. The Board of Trustees shall have the powers to co-operate not more than 6 Trustees for administrative convenience and the period of such nominated trustees shall be fixed by the present Trustees and they shall hold for such terms. The nominated trustees shall have no voting rights, The Trustees who are the signatories to this Trust shall hold Office to run the Trust.
